## **Camp Washington Industrial Area Plan**

The City of Cincinnati Development Department is nearing completion of the Industrial Plan. This plan identifies potential redevelopment areas, including two sites in the Northern part of Camp, and one site at the Southern of Spring Grove. In light of the announced closing of Ryerson, the I-75 improvement (displacing some of the City's public Wroks department), the vacant Kahn's and Crosley sites, and, the projected expansion of Kao Brands, this plan is very timely. City reps will be at the next Community Council meeting, October 12, to get feedback on the plan.

#### **Cover Discarded Mattress In Plastic**
