It has been downright depressing attending the recent City Budget meetings. As you may know, thanks to a nearly \$60 million projected deficit, both the Camp Washington Recreation Center and the Pool are slated to close in 2011. What is so distressing about this situation, is that the budget fight puts firemen and cops against kids. Cops, who have the most powerful union using the largest part of the public budget, always win lined up against politically-powerless kids. It's a terrible choice we have to make, as Camp Washington has been a fierce supporter of police and fire services.

It's pretty impressive that a few on City Council - Berding, Bortz, Qualls, Young - have proposed to eliminate the City police department, instead, using the Hamilton County Sheriff's Department. This is a bold idea, something that we expect from our leaders. For years, we have believed in crime prevention, and kids-at-risk using rec centers and pools certainly support that strategy.

We have to face the fact that with less public funding support, we have to change the way the City functions. A lot of painful cuts are going to affect the quality of life, and community volunteers are going to be more in demand.

#### Green Housing Template for 2969 Sidney Ave.

Energy costs are an integral component of housing development. The Camp Washington Community Board is using more and more of green technology in the course of rehabbing its housing projects.



For instance, we are incorporating new (and more expensive) insulation technologies. The Board has always done complete full demos and complete rehabs, since most of the housing stock we rehab are from 1870-1890 era when energy efficiency was not prevalent. Our customers are demanding better energy efficiencies. Financial realities of extracting more out of less are also forcing us to rely on getting better energy efficiencies.

The community board successfully applied for and received a Technical Assistance Grant through the City of Cincinnati. We will use these funds to incorporate the green technology template developed by SMK Designs as a model for more in-fill homes. Sean Keith, the owner architect of SMK Designs, has developed a Green Home Design model through a partnership with the Community Development Corporations of Greater Cincinnati. The CWCB has an ideal lot at 2969 Sidney Avenue on which to build this green home. Sean will make his template a sitespecific plan of action with real defined costs.
