# City Budget Cuts Pile Up Beds & Couches On Sidewalks and Lots

City Council in December 2010 voted to eliminate a vital neighborhood quality of life clean-up program run through the City's Litter Patrol. We are seeing a dramatic rise in abandoned couches, furniture, mattresses, box springs on neighborhood sidewalks. Regular Public Services garbage pick-up inconsistently removes these big items, even if

they're wrapped in plastic (to contain bed bugs).

Abandoned furniture on public spaces (including City-owned lots) seem to attract more garbage and junk. Ironically, when adjacent homeowners and businesses to this abandoned trash complain to the City,

THEY are often fined, as the trash grows and spreads onto their property!

This is another example of City Council creating poor policy with last-minute, ill-informed budgeting.

The City needs to generate revenue for good programs that make our neighborhoods attractive, clean and safe. City Council can sell billboard space on top of recreation centers. (Camp Washington rec center - now closed - sits right next to I-75 - a perfect spot for a billboard.)

Sell naming rights to roads, rec and health centers. Force owners of derelict eyesores such as the Crosley Building, Lunkenhiemer, abandoned corner gas stations to paint over the grafitti and rust and donate roof space to promote neighborhood activities with good, positive messages/sell ad space. Enforce Illegal Parking laws!

It is hard enough to keep our neighborhoods clean with volunteers. When you eliminate the City as a partner to fight blight and crime, it really puts more pressure on neighborhoods and local businesses. It will simply be a matter of time before this pressure builds up and breaks the will for folks to chip in and help the City. First, they stop volunteering and calling for help. Then, they move out of the City, and take their resources with them.

We need City Hall to step up and help.

On Thursday, August 11, the Metropolitan Sewer District of Greater Cincinnati will host the first of threee "Community Design Workshops" to explore design opportunities for the Lick Run Alternative Project.

This workshop will cover the entire Lick Run watershed, including the proposed conveyance system through South Fairmount (between Queen City and Westwood avenues east of White Street). Note: This area runs from the McDonalds near State Street all the way to the United Dairy Farmers on the west where Queen City splits.)
