It is very difficult to keep up with community problems that continually crop up. Problems such as grafitti, litter, scrapper thefts, pot holes, broken streetlights, drug dealers on your corner, illegal signs posted on poles.

It is very easy to report problems to the City of Cincinnati. You can call 591-6000 any time of the day and report your problem.

Or, go on-line to http://cagismaps.hamilton-co.org/ csrcincinnati/ and type in your problem. You can make a copy of the complaint before you email it so you'll have a record of it. You can also choose to have the City call or email you directly about the problem.

Recent problems reported include:

- pot holes on Bader
- overgrown weeds in Bates Alley
- abandoned furniture in Bangor Alley (off Stock)
- streetlight out at 2957 Massachusetts
- trash in the courtyard at 2936 Colerain
