Talbert House Buying Days Inn on Central Parkway for Transitional Housing

Talbert House is planning a transitional housing facility for seventy (70) men located at 2880 Central Parkway. Tenants will include men who are referred from the county's homeless shelters with a priority given to Veterans. Length of stay will be up to six months.

The goal of the program is to stabilize the men and secure permanent housing for them.

The West End, CUF, Queensgate, and Camp are seeing an increase in homeless shelters and post-release services in our area: City Link, City Gospel Mission, VOA, and, Spring Grove Talbert House.

Litter Fines Mount Up For Companies

Several companies in Camp Washington have complained of a rash of litter violation tickets handed out by the City's Litter Department. They plead for a warning so they can clean up the mess, but so far the City refuses to listen. If you are ticketed, FIGHT IT, by taking pictures of the clean up, and attending the hearing. Your litter ticket will usually be reduced in half.

Scrapper Law Being Changed

The Camp Washington Community Council is helping both state and local governments re-vamp scrapper laws.

For instance, Florida laws require that scrap be sold only from licensed vehicles, not from grocery carts, recycling bins, walk-ins. Every scrap transaction requires the recording of the license number.

Earl Weber, owner of Garden Street Metals, buys aluminum cans from walk-up scrappers, but has stopped buying other scrap metal from these people. This has helped cut down on the number of scrappers trolling through Camp Washington, stealing stuff and tearing through garbage set out for pick up. The community council is helping State Rep Denise Dreihaus develop an anti-scrap law to crack down on illegal scrapping.

Caution: catalytic converter thefts continue. Criminals usually sell these items to core facilities, not scrap yards.
